Abstinence in Overeaters Anonymous is the action of refraining from compulsive eating and compulsive food behaviors while working towards or maintaining a healthy body weight.

Spiritual, emotional and physical recovery is the result of working and living the Overeaters Anonymous Twelve Step program on a daily basis.

Motion B – Motion to allow change to definition of Abstinence and Recovery in years ending in zero DEFEATED 68-153

Motion C – Motion to change definition of Abstinence and Recovery-not addressed as Motion 1 adopted

Proposal 12 Move to amend regarding definition of hybrid groups so they can be registered as 1 group even though some meet face to face and some are on electronic devices

Proposal 13 and 14 NOT ON AGENDA- were moving to amend the wording of 12 steps and 12 traditions

Proposal 15 Move to amend to clarify representation of national service boards and language service boards as well as intergroups at WSBC ADOPTED WITH AMENDMENT 198-8

Proposal 16 Move to combine a subpart of Bylaws to clarify service bodies to cover all levels of service to include Intergroups, National Service Boards, Language Service Boards, Special Focus Service Boards and Regions ADOPTED WITH AMENDMENT 175-35
